#### Sub: <u>Domestic Flights under special consideration.</u>

Ref: No. 30.31.0000.112.42.001.21-1808, Dated: 19 April' 2021.

Following the government guidance and instruction, with effect from 0700 BST on 21 April 2021 until 2359 BST on 28 April 2021, limited numbers of schedule domestic passenger flights to/from selected destinations and the corporate flights of the Helicopter/General Aviation (by their owners only) are allowed to be operated under special consideration. All other flights will remain suspended except the operation of medevac and humanitarian/relief will continue as usual.

Standard disinfection, sanitization and social distancing procedure for passenger, crew, equipment and aircraft (inflight or on ground) shall strictly to be maintained/ followed for such flights.
